## Section 6: Trip payment, cancellation, and photo policies

### Payment Information

Deposit: A \$500 non-refundable/nontransferable deposit for the main trip and a completed registration packet are due from each individual participant by **June 30<sup>th</sup>, 2023**. Please note that a portion of this travel cost is tax deductible. We are happy to provide a letter for your records. If you prefer a Single room, please be sure to select the Single Room option during payment. **If you do not select this option upon registration, we cannot guarantee you a single room.**

Final payment: The remaining balance is due from each individual participant by **August 4<sup>th</sup>, 2023**. If you requested a shared room but did not designate a partner, the Fulbright Association will attempt to pair you with another participant. If another same-gender participant is not available, you will be asked to upgrade to a single room. Participant late payment: If you have not paid the full remaining balance by August 4<sup>th</sup>, 2023, Atlantic Tours & Travel is entitled to decide whether to cancel your participation in the trip without a refund or to offer a grace period for payment.

### Cancellation and Refund Policy

Participant cancellation: If a participant cancels their participation before July 30<sup>th</sup>, 2023, they will receive a full refund minus the non-refundable deposit. If a participant cancels their participation after July 30<sup>th</sup>, 2023, they will receive a refund of 50% of the amount that was paid above the \$500 non-refundable deposit. From the day of departure onward, 100% of the tour price will be retained.

Organizer cancellation: Atlantic Tours & Travel reserves the right to cancel the trip if participants' and staff's safety and security are in jeopardy. In the event that Atlantic Tours & Travel decides to cancel the tour for reasons beyond its control (which term will be defined as any acts of government, war, terrorism, revolution, or natural disaster in the destination country, as agreed between the parties herein will prevent Atlantic Tours & Travel from organizing a tour consistent with Atlantic Tours & Travel own tour program standards and the requirements of the Fulbright Association), at any time prior to the departure date, Atlantic Tours & Travel will refund to each participant all payments received, but neither Atlantic Tours & Travel nor the Fulbright Association can or will accept responsibility for any losses incurred to any participants by this cancellation although Atlantic Tours & Travel will make every reasonable effort to assist the participants in recouping their losses. Atlantic Tours & Travel shall be responsible for securing participant acknowledgment of this term and condition on behalf of itself and the Fulbright Association.

Trip Cancellation Insurance: Fulbright Association and Atlantic Tours & Travel strongly recommend that all participants purchase travel cancellation insurance to protect themselves against financial loss in the case of personal emergencies or other unforeseen events. If Atlantic Tours & Travel of FA cancels a trip for any reason, we will refund you the trip cost, but your airfare or the other travel expenses you purchase separately, may not be protected. At times you may be affected by circumstances beyond our/your control such as flight delays, missed connections, delays in Customs and/or Immigration, or the unfortunate event of terrorism, all of which can affect your trip or cause you to cancel your journey, so make sure that the insurance that you select will cover these events. We encourage you to shop around to purchase the best insurance provider for your needs.

## Section 7: Health Form

Travel of any kind can be stressful for your body. While traveling adequate healthcare, including certain medications, may not always be immediately available. If you take regular medication, please be sure that you bring enough with you to last the entire trip.

### Vaccinations and Immunizations

Travelers **must** be fully vaccinated with an FDA-authorized vaccine or vaccine authorized for emergency use by the World Health Organization against COVID-19. Furthermore, the CDC (Centers for Disease Control and Prevention, <https://www.cdc.gov/>) recommends the following vaccinations before traveling to Canada:

- Chickenpox (Varicella)
- Diphtheria-Tetanus-Pertussis
- Flu (influenza)
- Measles-Mumps-Rubella (MMR)
- Polio
- Shingles
- Hepatitis A: Consider for most travelers; recommended for travelers at higher risk (e.g., visiting smaller cities, villages, or rural areas where exposure might occur through food or water; or prone to "adventurous eating")
- Hepatitis B
- Rabies: Canada is free of dog rabies. However, rabies may still be present in wildlife species, particularly bats. CDC recommends rabies vaccination before travel only for people working directly with wildlife. These people may include veterinarians, animal handlers, field biologists, or laboratory workers working with specimens from mammalian species

### Health Insurance Information

All travelers must have health, emergency, and evacuation insurance for the period of the trip to cover their medical and related expenses in the event of an emergency. You are encouraged to ask your current insurance provider about what coverage you may already have. Supplemental travel health insurance is available from multiple providers.
